BYO iPad Student Participation Agreement

The following is to be READ and COMPLETED by both the STUDENT and the PARENT / LEGAL GUARDIAN:

- We have read, understood and accept the BYO iPad Acceptable Use Policy, the BYO iPad Parent Handbook and Student Code of Conduct (found in the Quick Links of the main page of the Oxley State School website).
- We agree to abide by the above rules.
- We are aware that any breaches of the BYO iPad Acceptable Use Policy may result in limited or no access to digital devices for a specified period as per the school's Student Code of Conduct and in relation to the severity of the offence.
- **The points below combine information from the Oxley State School BYO iPad Acceptable Use Policy and the BYO iPad Program Parent Handbook, accessible through the school website.**

General Use

1. I understand that I need to bring my personal iPad to school each day, unless otherwise instructed by my teacher.
2. I will ensure my iPad is fully charged at the beginning of each school day and understand that it cannot be charged at school.
3. I will leave the iPad charger at home.
4. I will keep my iPad in a heavy-duty cover at all times.
5. I am required to keep my iPad in its protective carry case in my school bag on my trip to/from school.
6. I will keep my bag with me at all times before school, until the 8:30am bell, when I will take it to my class's designated area.
7. When I am not using my iPad, I will store it in the allocated storage box in the lockable iPad cupboard in my classroom, as directed by my teacher.
8. I will hold the iPad with two hands when carrying it and will walk with it at all times.
9. I will keep food and drinks away from the iPad at school.
10. I will immediately report any accidents or breakages to my parents and my teachers.
11. If damage is caused by deliberate or careless actions of a student (owner or others), the costs of repair will be passed on to those involved and necessary behaviour consequences may apply.
12. I will not use my iPad before or after school, or at break times unless with teacher supervision.
13. At times, I may be asked to work with other students for the purposes of collaboration, however other students must not use my iPad.
14. I will not allow other students to be in possession of my iPad.
15. I will ensure date, time and region are correct on my iPad.

Content

1. I will download the required apps through the Company Portal app (Microsoft Intune) before I bring it to school for the first time.
2. I will disable VPNs (Virtual Private Networks) on the iPad, so I can connect to the school network.
3. Whilst at school, I will only use my iPad to support my school learning program.
4. I permit my teachers and parents (in presence of the student) to perform checks to monitor that I have not installed illegal/unsuitable software applications and content and to check the websites which I visit.
5. I understand there will be consequences for inappropriate use including, but not limited to, loss of privilege of using the iPad for a period of time.
6. I will not delete school work from my iPad, unless instructed by my teacher.
7. I am responsible to ensure my iPad is backed up.



8. I understand that if any inappropriate content appears on my iPad, I am to immediately turn off the screen of my iPad and take it to my teacher.

Safety and Security

1. Whilst at school, I will only connect my iPad to Education Queensland's Managed Internet Service (EQNET/ iDET). I am not permitted to access 3G/4G/5G internet at school.
2. I will provide my teacher/ school staff full access to my iPad through the Classroom app.
3. Whilst at school, I will only go to websites that support my learning activities, as instructed by my teacher.
4. Whilst at school, I will only use Airdrop if directed by my teacher.
5. I will demonstrate etiquette when using my iPad and other equipment with regard to other people.
6. I will only take photos and record sound or video of staff and students, when granted permission by my teacher and the individual concerned.
7. When using email or the internet, I will not share names, images, addresses or phone numbers.
8. The school name, crest or uniform will not be used without permission from the principal, or in any way which would result in a negative impact for the school and its community. I will not post photos, audio or video of such.
9. I will use my iPad lawfully and in accordance with the Oxley State School Student Code of Conduct.
10. For security reasons, I am not to share account names and passwords with anyone unless requested by Oxley State School, when servicing my iPad.
11. I am responsible for the security, safety and use of my iPad while at Oxley State School.
12. **I will not use the Messages app or other messaging apps or websites while at school.**
13. **I will not use Generative AI tools (ChatGPT, Copilot, CanvaAI or similar).**

I (the student) understand that failure to follow the above conditions may result in the loss of access to my iPad, other digital devices, or the school network (internet) at Oxley State School for a period determined by my class teacher and the principal. I also acknowledge that repeated breaches of the agreement may lead to an extended time without iPad usage and network access privileges at school.
